
Main objectives of the Trust:

- g) Financially assisting to the trust like institutions asking for our help.
- h) Conducting Free Medical Camp, Free Eye Camp, Blood Donation Camp and all other Medical Camps, Medical Awareness Camp for all types of diseases, Research Seminars, Providing meals, clothes and other facilities,
- Providing free food, free staying, free clothes and other facilities to the poor people, widows and destitute people.

All Educational Institutions and other Institutions established by the Trust should work for the objectives of the Trust should not work to gain profit.

Policy of the Trust:

The amount given by us, the properties purchased or accumulated for the trust in future, amount received through profit, properties bought by the profit, donations given by others will be considered as trust's property. We have all rights to spend money from the above said trust income for the trust's development. All gifts and donations given for a specific resolution of the trust will be considered as it belonged to the trust.

Management of the Trust:

- When we intend to establish CBSE School and other Schools, Arts College, Technical College, Medical College and other organizations through the trust in future we can purchase lands, house sites, buildings, movable and immovable properties and through donations, exchange, lease, installment and rent.
- For the necessity of the development of the trust, with the acceptance of the trust committee, the properties vested to the trust in future can be sold, mortgaged, leased, rented or exchanged in otherwise and engaging in all types of agreement of rejecting it.
- 3. Availing loan in future for the development of the trust from Schedule Banks, Public Ltd. Banks and other persons with pledge or without pledge and when availing loan from the banks with mortgage of the trust properties and repaying the loan and to sign in the documents to execute them.
- Beginning accounts in banks and maintaining it through any two of the three persons nominated by us as Chairman, Secretary and Treasurer.
- Investing and exchanging the investment of the surplus funds of the trust for the welfare of the trust.
- Collecting all the receiving of the trust and to do necessary steps to collect them and to issue receipts and to canceling the loans.
- Appointing employees, terminating, with held the employees and other activities for the trust administration work and availing funds from other organizations for their welfare.

8. Nominating Advocates for the trust to appear in State and Central and Public Offices etc. Institutions for Justice, Tribunals.

- Conducting all legal proceedings and all disputes and defending the case.
- Receiving donations, gifts from anybody for the trust and maintaining them for the objectives and conditions of the trust.
- Spending necessary expenses for the administration of the trust.

- 13. On every year March 31st day trust's correct account should be completed and should be audited by a Chartered Accountant. That should be reviewed in the yearly meeting and should be approved.
- 14. According to the trust management and works, rules of the trust may be changed, cancelled, added on the basis of the resolution by the majority members of the trust committee only.
- 15. Paying the expenses for the trust's administration and works and collecting the receiving of the trust.
- 16. Executive Committee of the trust cannot be changed. Even then for the execution of the trust objectives and progress of the trust if all of us intend we can change the Executive Committee at any time.
- 17. For the welfare of the trust and for the excellence of the trust rules and committees may be formed without any contradiction of the trust motive.
- 18. Trust will be managed by the committee elected by all of us.
- 19. After the life time of a member of the trust one of his legal heirs, decided by them in writing, will continue as the member of the trust. If any member of the trust like to leave from the trust new member can be allowed in that place on the basis of the resolution by majority members of the trust.

The Executive Committee have all rights to do works for the progress of the trust educational and charity works.

DO NOT OF THE EXECUTIVE COMMITTEE:

1. Any individual member of the trust or Executive Committee should not collect money without account, sale or mortgage or lease the trust property using the trust's name.

- Revenue and Properties of the trust should not be changed into individuals name. 4.

Members or the Executive Committee Member who will violate the above said rules will lost their position in the trust and will be disqualified from the trust membership.

- Trust is irrevocable. 5.
- If this trust is to be liquidated properties vested to it on that day should not be 6. divided among the members of the trust. They should be transferred to the educational and charities registered under Indian Income Tax Act 1961.
- If any changes should be taken in the rules of this deed it should be done under Indian Income Tax Act 1961 Rules 2 (15), 11, 12, 13 and 80G and not against the basic motive of the trust.
- The benefits of the trust should be availed by all the Indian Citizens without the 8. discrimination of Community, religion, race and language.
- The objectives of the trust can be executed in the Indian Union only. 9.
- Any changes in the rules of the trust may be done only after the written permission of the relevant segment Income Tax Commissioner.
- We assure that the trust did not have any movable or immovable property. 11.
- The gains any amounts received by the trust should be used only for achieving 12. its objectives and it should not be divided as profit or dividend to anybody.




